#### What do we mean by safety culture?

'Culture' can be defined as the way of life, general customs and beliefs of a group of people.

Safety culture is a combination of the attitudes, values and perceptions that influence how something is actually done in the workplace, rather than how it should be done

# Safety culture can be a significant factor in poor health and safety

King's Cross fire 1987 -The Fennell report, stated that:

"a cultural change in management is required throughout the organisation."

Piper Alpha oil rig disaster 1988 - Lord Cullen's report stated:

"it is essential to create a corporate atmosphere or culture in which safety is understood to be, and is accepted as, the number one priority."

#### Health & Safety at Work etc Act 1974

General duties of employers to their employees.

2. (1) It shall be the duty of every employer to ensure, so far as is reasonably practicable, the health, safety and welfare at work of all his employees.

#### Health & Safety at Work etc Act 1974

#### General duties of employees at work

7. It shall be the duty of every employee while at work

\* to take reasonable care for the health and safety of himself and of other persons who may be affected by his acts or omissions at work; and

\* as regards any duty or requirement imposed on his employer or any other person by or under any of the relevant statutory provisions, to co-operate with him so far as is necessary to enable that duty or requirement to be performed or complied with.

# UK Work Culture

TUC and ONS

UK workers already work long hours

UK employers claimed £27 billion of free labour last year because of worker's unpaid overtime.

3.8 million people did unpaid overtime in 2021, putting in an average of 7.6 unpaid hours a week.

Equivalent to £7,100 a year of wages

#### HSE and Safety Culture

Many companies use the term 'safety culture' to refer to the inclination of workers to act safely or unsafely,

But

The culture and style of management is more significant.

For example, managers may:

- ▶ Have a natural, unconscious bias for production over safety
- ▶ Tend to focus on the short-term and be highly reactive
- Ignore health and safety policies and procedures that are in place.

#### Health and safety statistics

Key figures for Great Britain 2022-23 (HSE or LFS where stated)

- ▶ 135 workers killed in work-related accidents (note: not all deaths)
- ▶ 12,000 deaths due to lung disease due to past exposure
- 2,268 mesothelioma deaths due to past asbestos exposure
- ▶ 565,000 working people sustained an injury at work LFS

Yet only

▶ 61,713 injuries to employees reported under RIDDOR

#### Health and safety statistics (contd)

1.8 million working people suffering from a work-related illness,

914,000 workers suffering work-related stress, depression or anxiety

477,000 workers suffering from a work-related musculoskeletal disorder

123,000 workers suffering from COVID-19 which may have been from exposure at work

36.8 million working days lost due to work-related illness and workplace injury

£18.8 billion estimated cost of injuries and ill health from current working conditions (2019/20)

#### Costs to UK Economy

In 2020 Deloitte Reported that poor mental health costs UK employers up to £45 billion a year


For every £1 spent by employers on mental health interventions they get £5 back in reduced absence, presenteeism and staff turnover

#### And for organisations

- ▶ Increased accidents
- production delays,
- higher rates of absence,
- poor staff retention
- ▶ Inflated insurance premiums
- ▶ Fines
- Reputational damage
- ▶ loss of revenue
